#### 2.2Development & Heritage - Paul

- Meeting with Kingsett scheduled Zoom meeting was held with Tom Giancos. Tom outlined Kingsett's plan to develop 68 Wellesley E. Tom pointed out they intend to ignore the 45degree angle as it would reduce the space available and make the site nonviable for development. Tom said the development would be 28 floors with a potential community space on the first two floors on the north side of the development. There was discussion about accessibility to services for the site as Anvil Alley is a public lane and narrow. Tom indicated the north edge of the site would be used as access.
- Heritage Status re expiring listings on Heritage register Heritage Planning is actively considering and will report early 2024. The sense is that should an application come in for a site that is not on the register it can be listed quickly since listing authority is now delegated to the Chief Planner.
